August 23	Candidates/	DECLARTION OF CANDIDACY AND NOMINATION PAPERS – INDEPENDENT PRESIDENTIAL ELECTORS (E.C. §§ 8403, 8550)
Dec. 06 (193 – 88)	Registrar of Voters	Between these dates a candidate may obtain Nomination Petitions and the Declaration of Candidacy from the Registrar of Voters.
Sept. 12 - Nov. 6 (173 – 118)	Candidates/ Registrar of Voters	PETITION IN-LIEU OF FILING FEE – ALL CANDIDATES (E.C. §§ 8061, 8105, 8106) Forms may be obtained from the County Election Official during this period. Petition forms may be obtained to secure signatures in-lieu of all or a portion of the filing fee. Signatures submitted on the in-lieu petitions may also be applied to the signature requirements for offices on the nominating petition.

Sept. 27 - Dec. 6 (158-88)	Candidates/ Registrar of Voters	DECLARTION OF CANDIDACY AND NOMINATION PAPERS – CENTRAL COMMITTEE CANDIDATES (E.C. §§ 8001, 8020) Between these dates a candidate may obtain and file a Declaration of Candidacy with the Registrar of Voters. The ballot designation worksheet must be filed at the same time as the Declaration of Candidacy.
October 28 - November 6 (127 – 118)	Candidates/ Registrar of Voters	DECLARATION OF INTENT OF JUDICIAL CANDIDATES (E.C. §§ 8023, 8105) Every candidate for a judicial office shall file with the County Elections Official a written and signed declaration of his or her intention to become a candidate for Superior Court Judge and designate the seat number they are seeking. Nonrefundable filing fees must be paid at the time the declaration of intent is filed.

November 7 - Nov. 11 (117 – 113)	Candidates/ Registrar of Voters	EXTENSION OF DECLARATION OF INTENTION – JUDICIAL (E.C. §§ 8023, 8105) If the incumbent for a judicial office does not file a declaration of intention to succeed to the same office by the end of the Declaration of Intent Filing Period, qualified persons other than the incumbent may file a declaration of intention for that office during this extension period. Nonrefundable filing fees must be paid at the time the declaration of intent is filed.
November 4 December 4 (120 – 90)	Registrar of Voters/ District Secretary	PUBLISH NOTICE OF ELECTION (E.C. §§ 12109, 12112, 12113) Publish a single Notice of Election between these dates containing the following: ✓ Date of Election ✓ Name of each office for which candidates may file ✓ Qualifications required for each office ✓ Location where Declaration of Candidacy may be obtained ✓ Office in which completed declarations are to be filed ✓ Statement that appointment(s) to office will be made if there are insufficient nominees and no petition is filed requesting the election be held ✓ Location of Central Ballot Counting
November 11 - December 6 (113 – 88)	Candidates/ Registrar of Voters/ District Secretary	DECLARTION OF CANDIDACY AND NOMINATION PAPERS (E.C. §§ 8020, 10510, 13107) Between these dates a candidate may obtain and file a Declaration of Candidacy with the Registrar of Voters. The ballot designation worksheet must be filed at the same time as the Declaration of Candidacy.
November 11 – December 6 (113 – 88)	Candidates/ Registrar of Voters/ District Secretary	CANDIDATE STATEMENT (E.C. §§ 10540, 13307, 13309, 13311, 18351) If office sought requires nomination papers, candidate statement is due at time of filing nomination paperwork. Candidate statements are confidential until the deadline for filing has passed.
December 7 – 16 (87-78)		PUBLIC EXAM OF CANDIDATE STATEMENTS (E.C. § 13313) During this 10-day period the Registrar of voters will make candidates' statements available for public examination.
November 11 – December 6 (113-88)	Candidates/ Registrar of Voters	STATEMENT OF ECONOMINC INTEREST (E.C. §§ G.C. 87200 et seq., 87300 et seq.) A Statement of Economic Interests must be filed for all candidates with the Registrar of Voters by the close of the nomination period.
November 11 (113)	Candidates/ Registrar of Voters/ District Secretary	CODE OF FAIR CAMPAIGN PRACTICES (E.C. § 20400 et seq.) Candidates are issued the Code of Fair Campaign Practices at the same time nomination papers are issued. Filing is voluntary and may be filed any time prior to the election; and, is available for public inspection until 30 days after the election.

		LAST DAY TO FILE DECLARATION OF CANDIDACY OR WITHDRAW CANDIDACY (E.C. § 10510)
December 6 (88)	Candidates/ Registrar of Voters	Last day for candidates to file their Declarations of Candidacy and Candidate Statements with the Registrar of Voters no later than 5 p.m. (unless there is an extension of the nomination period). Last day to withdraw candidacy unless there is an extension.
December 9 (85)	Candidates/ Registrar of Voters	LAST DAY TO WITHDRAW CANDIDATE STATEMENT (E.C. § 13307) Last day to withdraw candidate statement (next working day after close of nomination), unless there is an extension of the nomination period. Withdrawal of candidate statement must be in writing.
December 11 (83)	Candidates/ Registrar of Voters/ District	EXTENSION OF NOMINATION PERIOD (E.C. §§ 8022, 8024, 10510, 10516) If the incumbent does not file by 5 p.m. on the last day of the nomination period (December 6), any eligible person, other than the incumbent, shall have until 5 p.m. on December 11 to file a Declaration of Candidacy. The nomination extension does not apply where there is no incumbent to be elected. If this section is applicable, a candidate may withdraw his or her Declaration of Candidacy up until 5 p.m. on December 11.
December 12 (82)		LAST DAY TO WITHDRAW CANDIDATE STATEMENT (EXTENSION) (E.C. §§ 8024, 10516, 13307) In the event there is an extension of the nomination period, candidates may have until 5 p.m. on March 17 to withdraw their candidate statement. Withdrawal must be in writing.
December 12 - 21 (82-73)		PUBLIC EXAM FOR EXTENSION (E.C. § 13313) During this 10-day period the Registrar of voters will make candidates' statements available for public examination.
December	Registrar of Voters / District Secretary	NOTICE OF WHETHER ELECTION WILL BE HELD (E.C. § 10515) If there are insufficient nominees for the offices to be filled, and a petition requesting the election be held has not been presented to the officer conducting the election, then the election shall not be held. The Registrar of Voters shall request the Board of Supervisors to appoint the qualified candidate(s) to such office. If there are no candidates, the Board shall appoint a qualified person to each office. Persons appointed shall qualify, and serve as if elected.

Statements must be sent by personal delivery or first class mail.

January 6 - February 18 (57 -14)	Candidates/ Registrar of Voters	NOMINATION PERIOD FOR WRITE-IN CANDIDATES (E.C. § 8600, 8601 et seq.) Nomination papers for write-in candidacy will be available beginning January 6 and must be filed with the Registrar of Voters no later than 5 p.m. on February 18.
February 20, 2020	Candidates/ Committees/ Registrar of Voters	FILING PERIOD FOR SECOND PRE-ELECTION CAMPAIGN DISCLOSURE STATEMENT (G.C. §§ 84200.5, 84200.7) ***UPDATE/REVIEW ONCE FPPC PUBLISHES*** Filing period for 2 nd pre-election campaign statement covers transactions through February 15, 2020. Statements must be sent by personal delivery or guaranteed overnight delivery.
January 1 – 31	Candidates/ Committees/ Registrar of Voters	FILING PERIOD FOR SEMI-ANNUAL CAMPAIGN DISCLOSURE STATEMENT (G.C. § 84200) Statement covers transactions through December 31. Statements must be sent by personal delivery or first class mail.
